I, the undersigned, T. Erik Oaas and Dena L. Banducci, hereby declare that (1) they are the Vice President Finance, Treasurer and the Secretary, respectively, of Micron Custom Manufacturing Services, Inc., an Idaho corporation (the "Company"); (2) that the original Articles of Incorporation of the Company were filed with the Secretary of State of the State of Idaho on July 30, 1992, and (3) that the following amendment to the Company's Articles of Incorporation was approved by written consent of the sole shareholder of the Company on December 16, 1993.

Increase in Authorized Shares:

1. Article IV of the Company's Articles of Incorporation shall be amended to read in its entirety as follows:

"Article IV

The aggregate number of shares the corporation will have authority to issue is ten million (10,000,000) shares of \$0.10 par value per share common stock."
