



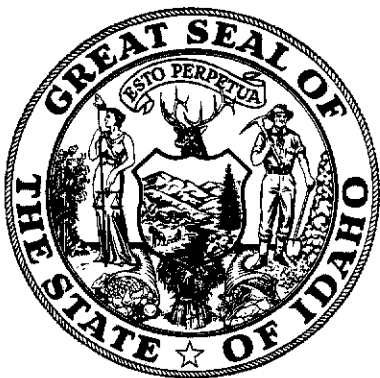
CERTIFICATE OF INCORPORATION

OF

The undersigned, acting as incorporator of the corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I.

The name of the corporation is:

EXCEL CONTRACTORS, INC.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purpose or purposes for which the corporation is organized are to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

The aggregate number of shares which the corporation shall have authority to issue is twenty-five thousand (25,000) shares, having a par value of One Dollar (\$1) per share.
