The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is ALENSKIS ENTERPRISES, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III
