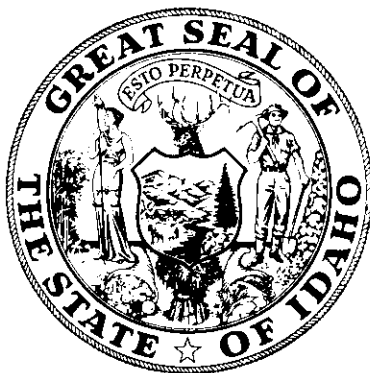

ARTICLE III. The notice to creditors required by Section 30-1-87, Idaho Code, has been given.


ARTICLE IV. All debts, obligations and liabilities of the corporation have been paid and discharged.




