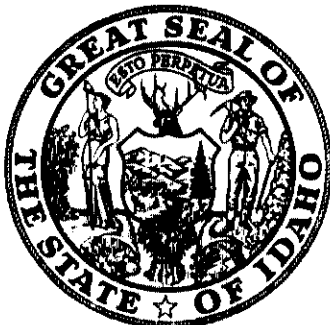
### CERTIFICATE OF INCORPORATION OF

#### ARTICLE I

The corporation formed herein shall be known, from the date of its incorporation until altered or said corporation is dissolved, as Snyder's Home Center, Inc.

#### ARTICLE II

The corporation herein formed shall have a perpetual duration and shall remain in existence according to the law of the State of Idaho until such time as said corporation is effectively dissolved by voluntary will, or by operation of law.

#### ARTICLE III

The purpose of the corporation herein formed shall be to transact all lawful business for which a corporation may be formed in the State of Idaho, as from time to time said corporation may deem desirable for benefit of said corporation; said benefits to be in the exclusive discretion of the Directors.

#### ARTICLE IV

There shall be only one class of stock, know as Common Stock, issued by the corporation.

#### ARTICLE V

The corporation shall be authorized to issue One Hundred Thousand Shares (100,000) of capital Common Stock at a par value of Ten Cents (\$0.10) per share.

#### ARTICLE VII

The initial registered office of the corporation shall be 1120 American Ridge Road, Juliaetta, Idaho, 83535.

#### ARTICLE VIII

The initial registered agent of said corporation, residing within the State of Idaho, shall be Raymond L. Snyder, whose address is 1120 American Ridge Road, Juliaetta, Idaho, 83535.

#### ARTICLE IX

There shall be no fewer than one Director of the Corporation; initially there shall be a single Director in said corporation to serve in such office until time there is a first meeting of shareholders to elect permanent Directors to serve in said position for a period of one year. The following person, namely Raymond L. Snyder, of Juliaetta, Idaho, shall be the initial Director.

#### ARTICLE X

The Incorporator of Snyder's Home Center, Inc., is Raymond L. Snyder, of Juliaetta.
