ARTICLES OF INCORPORATION

OF

THE NORTH WAY OWNERS ASSOCIATION, INC.

I, the undersigned, acting as the Incorporator of a non-profit corporation under the Idaho Nonprofit Corporation Act, I.C., §30-301, et. seq., adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is The North Way Owners Association, Inc.

ARTICLE II

The corporation shall be a non-profit membership corporation where pecuniary profit is not an objective.

ARTICLE III

The period of duration of the corporation is perpetual.

ARTICLE IV

The purpose of the corporation is to act as the Management Body, as that term is defined in the Idaho Condominium Property Act, for The North Way Condominiums in the City of Ketchum, Blaine County, Idaho, as provided for by the terms and conditions of the Condominium Declaration for The North Way Condominiums which shall be recorded in the Office of the County Recorder for Blaine County, Idaho, together with a certified copy of these Articles of Incorporation appended thereto.

ARTICLE V

The Class A members shall consist of and include all owners of condominiums within The North Way Condominium project in the City of Ketchum, Blaine County, Idaho. No person who is not an owner of such a condominium may be a Class A member of the corporation. The Class B member shall be The North Way, Ltd., an Idaho limited partnership, the developer and initial owner of The North Way Condominium project.

1 - ARTICLES OF INCORPORATION

ARTICLE VI

The address of the initial registered office of the corporation is 220 East Avenue, Post Office Box PP, Ketchum, Idaho, 83340, and the name of its initial registered agent at such address is Campion & Hogue, an Idaho Professional corporation.

ARTICLE VII

The number of Directors constituting the initial Board of Directors of the corporation is three (3), and the names and addresses of the persons who are to serve as Directors until the first annual meeting of the members or until their successors are elected and shall qualify are:
