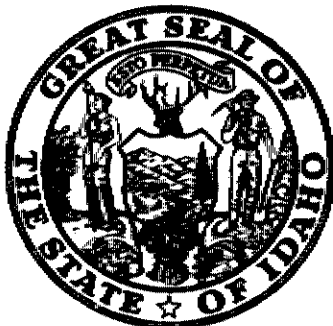
### CERTIFICATE OF AMENDMENT OF

Pursuant to the provisions of § 30-1-61 of the Idaho Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:       The name of the Corporation is Hunting, Inc.**

**SECOND:     The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the Corporation on the 26th day of February, 1993, in the manner prescribed by the Idaho Business Corporation Act. Article V of the Articles of Incorporation is amended to read as follows:**

**ARTICLE V**

**The governing board of this corporation shall be called the Board of Directors which shall consist of at least one (1) and not more than two (2) members, the number to be designated by the By-laws consistent with this Article. The first Board of Directors and Incorporators shall consist of one (1) member, whose name and address is as follows:**

**THIRD:     The number of shares of the corporation outstanding at the time of such adoption was 6,000. All of the stockholders of the corporation executed an agreement in lieu of a meeting and adopted the above amendment on the 26th day of February, 1993. The Board of Directors also adopted the described amendment by an agreement in lieu of a special meeting of the Board of Directors on the 26th day of February, 1993. The Board of Directors authorized the President and Secretary to cause Articles of Amendment to be**

prepared, sworn to and filed as required by law to accomplish the amendment of the Articles of Incorporation in accordance with the agreement in lieu of a special meeting of the stockholders.
