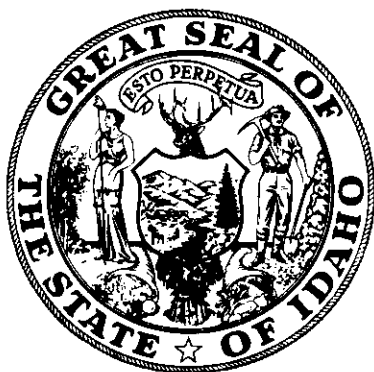

ARTICLES OF INCORPORATION
SECRETARY OF STATE

The undersigned, acting as incorporator under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is Westcon Associates, Inc.

ARTICLE TWO

DURATION

The duration of the corporation shall be perpetual.

ARTICLE THREE

PURPOSES AND POWERS

The purposes of the corporation and its powers are the following:

The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE FOUR

STOCK

The aggregate number of shares which the corporation shall have authority to issue is 100,000 in number and shall be of \$1.00

par value. Said shares of stock shall be fully paid for before being issued, and after issuance shall be nonassessable.

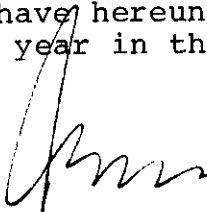
