

The undersigned natural person of the age of twenty-one years or more, acting as incorporator under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I The name of this corporation is LEONARD MARTIN TRUCKING CO., INC., and its duration shall be perpetual.

ARTICLE II The purpose or purposes for which the corporation is organized are:

1. To engage generally in the business of motor transport for hire and in connection therewith to own, lease, rent, buy and sell trucks and other motor transport vehicles.
2. To engage in any lawful business for which corporations may be formed under Title 30, Section 101 et. seq. of the Idaho Code (Idaho Business Corporation Act).

ARTICLE III The aggregate number of shares which the corporation shall have authority to issue is 300 shares of common stock without par value.
