
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that I, Kenneth D. Montee, over the age of eighteen, have this day voluntarily come for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and I do thereby certify the following Articles of Incorporation, as follows:

I.

The name of the corporation shall be SEA-LIFE, INC.

II.

The period of duration of the corporation shall be perpetual.

III.

In addition to the powers granted to the corporation by the State of Idaho, the purposes of this corporation as formed are as follows:

To acquire by purchase or lease or otherwise, lands or interests in lands; to own, to hold, improve, develop and/or manage any real estate; for the purposes of removing mineral and energy resources, by various acceptable or experimental technique on any lands owned, held or occupied by the corporation; to alter or improve any site or environmental distraction now or hereafter on any lands so owned, held or occupied or otherwise located; to borrow money; to lend money; to conduct a general mineral and energy resource agency and commission business for others in the purchase, sale and management of mineral and energy resource property; to purchase and sell personal property of all kinds used for mineral and energy resource purposes, stocks, bonds, and notes; to negotiate loans thereon, to extract to process or mill to manufacture and market mineral and energy resource products of all kinds natural or incidental to the conduct of said business, and all other powers necessary or incidental to the conduct of said business; and to do all acts permitted by the general business incorporation law of Idaho and all other such acts as are necessary and expedient to accomplish these stated purposes.

IV.

The Corporation shall have the authority to issue Fifty Million (50,000,000) shares of common stock having a \$0.001 par

value per share.

V.

The Corporation shall not commence business until consideration of the value of at least Five Hundred Dollars (\$500.00) has been received for the issuance of shares.

VI.

Preemptive rights of shareholders to acquire additional shares of the Corporation shall not exist. Cumulative voting rights shall not exist.

VII.

The management of this Corporation shall be vested in the Board of Directors and the number of directors shall not be less than one, and the number, qualification, terms of office, manner of election, place and time of meetings, and powers and duties shall be such as prescribed by the Bylaws of the Corporation.

The authority to make Bylaws for the Corporation is hereby expressly vested in the Board of Directors of this Corporation subject to the power of the shareholders to change or repeal such Bylaws.
