

DESIGNATION OF AGENT AND ACCEPTANCE OF THE PROVISIONS OF THE
CONSTITUTION OF THE STATE OF IDAHO

KNOW ALL MEN BY THESE PRESENTS:

That JACOBSEN MANUFACTURING COMPANY
a Corporation organized and existing under the laws of the State of WISCONSIN

plated by the provisions thereof, relating to such acceptance by other than municipal corporations.
