P R O C L A M A T I O N

EUGENE W. SHELLWORTH, Mayor of Boise City, a municipal corporation situate in Ada County, Idaho, organized and heretofore operating under a special charter, being an Act of the Third Legislative Assembly of the Territory of Idaho, entitled "An Act to Incorporate Boise City, in Ada County," (approved January 11, 1866), having filed in the Office of the Governor of the State of Idaho a certificate of election and a certificate of population, as required by Chapter 227, 1961 Session Laws of the State of Idaho, and it appearing that:

At an election held under the provisions of Chapter 227, 1961 Session Laws of the State of Idaho, within the corporate limits of Boise City on August 22, 1961, the following proposition was submitted to the qualified electors of said city:

"Shall The Proposition to organize Boise City as a City of the First Class, under Title 50, Idaho Code, and the General Laws of the State of Idaho, be adopted?"

At said election 3693 electors cast their ballots in favor of said proposition and 151 electors cast their ballots as opposed to said proposition.

That the population of Boise City as ascertained by the census taken in 1960 under the laws of the United States was 34,481.


NOW, THEREFORE, I, ROBERT E. SHYLLIE, Governor of the State of Idaho, do hereby by public proclamation declare

Boise City, a municipal corporation situate in Ada County, Idaho, to be a City of the First Class defined and governed by Title 50, Idaho Code, and the General Laws of the State of Idaho.

Given under the official seal of the State of Idaho this 1st day of September, 1961.



IN WITNESS WHEREOF, I have hereunto set my hand and caused to be affixed the Great Seal of the State of Idaho at Boise, the Capital, the 1st day of September, in the Year of our Lord Nineteen Hundred and Sixty-one and of the Independence of the United States the One Hundred and Eighty-sixth.
