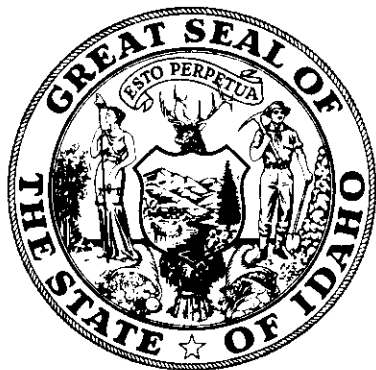

ARTICLES OF INCORPORATION
OF
CITIZENS AGAINST POACHING, INC.

The undersigned persons acting as incorporators for a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Citizens Against Poaching, Inc.

SECOND: The corporation is a nonprofit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The corporation is organized for the charitable and educational purposes of preserving and protecting the wildlife resources in the state of Idaho by the following means:

1. Creating and maintaining, through soliciting and receiving contributions, a fund for the payment of rewards for information leading to the apprehension of wildlife law violators;
2. Attempting to reduce the number of wildlife law violations;
3. Increasing the rate of detection and apprehension of wildlife law violators; and
4. Educating the citizens of Idaho about the incidence of wildlife law violations and about the detection and apprehension of wildlife violators by providing information leading to the apprehension of such violators.

FIFTH: The corporation shall have the power to do all lawful acts necessary or desirable to carry out its purposes, consistent with the provisions of the Idaho Nonprofit Corporation Act and Section 501(c)(3) of the Internal Revenue Code.

SIXTH: Upon dissolution of this corporation, any assets remaining thereafter shall be delivered to and become the property of the Idaho Department of Fish and Game, or to its successors in interest, to be kept, allocated or otherwise disposed of in accordance with policies and procedures of such Department, or its successors in interest, then in effect relating to the preservation and protection of wildlife.

SEVENTH: The street address of the initial registered office of this corporation is Suite B, 815 W. Washington Street, Boise, Idaho, and the name of the initial registered agent at such address is Byron Johnson.

EIGHTH: The number of directors constituting the board of directors of the corporation is six and the names and addresses of the persons who are to serve as directors until the first annual meeting of the members or until their successors are elected and shall qualify are:
