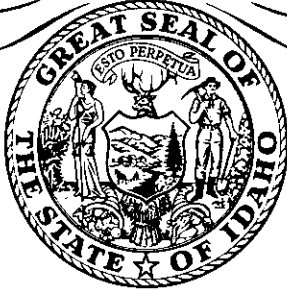

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

**RIGGINS MERC, INC.**

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Eleventh** day of **June**, 19 **63** original articles of amendment, as provided by Section s **30-146, 30-147, and 30-148, Idaho Code**, amending **ARTICLE VI** increasing capital stock to **\$200,000.00** divided into **20,000 shares @ par value of \$10.00 each**,

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. **124** of Record of Domestic Corporations of the State of Idaho.

8 We, the undersigned, GUS CARLSON and OPAL CARLSON, respectively  
9 the President and Secretary of the Riggins Merc, Inc., a corporation  
10 existing under and pursuant to the provisions and laws of the  
11 State of Idaho, do hereby certify that at a special meeting of the  
12 stock holders of said corporation, held at Riggins, County of Idaho,  
13 State of Idaho, on the 30th day of April, 1963, pursuant to notice  
14 given thirty days prior thereto to the share holders of the time,  
15 place, and specific purpose thereof, namely, to increase the capital  
16 stock of the said corporation, at which meeting all the total  
17 number of shares were present and represented, the following  
18 resolution was unanimously adopted:

20 RESOLVED, That Article VI of the Articles of Incorporation  
21 be in the same is hereby amended to read as follows:

22 ARTICLE VI.

23 The capital stock of this corporation shall be two hundred  
24 thousand dollars (\$200,000), divided into twenty thousand shares  
25 of stock with the par value of ten dollars (\$10) each. No distinction  
26 shall exist between the shares of this corporation and all such  
27 shares shall have the same rights in the corporation.
