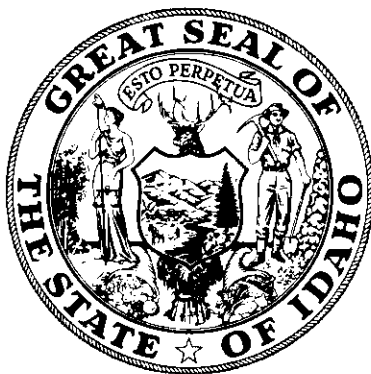

ARTICLES OF INCORPORATION

ARTICLE I

NAME

The name of this corporation shall be PURPLE SAGE BAPTIST CHURCH of CALDWELL, Inc., CANYON COUNTY, IDAHO, and the principle place of conducting its business shall be CALDWELL, CANYON COUNTY, IDAHO.

ARTICLE II

DECLARATION

This corporation is a NON-PROFIT organization in that it is to enhance the Word of our Lord and to help others.

ARTICLE III

LIFE OF THE CORPORATION

The duration of this corporation shall be perpetual.

ARTICLE IV

PURPOSES

The purposes for which this corporation is organized are:

1. To glorify the Lord Jesus Christ.
2. To propagate and disseminate the truths and teachings of the Holy Bible consisting of the Old and New Testaments.
3. To bring men and women into a personal knowledge of Jesus Christ as their Lord and Saviour.
4. To establish and maintain a place of worship where believers in the Lord Jesus Christ can assemble together for such purposes.
5. To establish and maintain institutes for the education of our children, and for the training of those who sense the call of God for Christian service.
