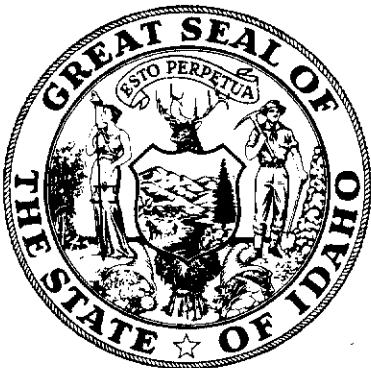

ARTICLES OF INCORPORATION

FAT STOCK SALE COMMITTEE, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Twin Falls County 4H - FFA Fat Stock Sale Committee, Inc.

ARTICLE II

The corporation herein organized is and shall be a nonprofit membership corporation.

ARTICLE III

The period of duration of the corporation is perpetual.

ARTICLE IV

The purpose or purposes for which the corporation is organized are:

- (a) To promote and conduct the sale of fat stock owned and grown by 4H and FFA youth members in Twin Falls County, Idaho.
- (b) To promote educational programs regarding the raising of cattle, hogs and sheep by the youth residing in Twin Falls County, Idaho.
- (c) To engage in such other educational activities for the youth residing in Twin Falls County, Idaho, as may be

1 lawful under the statutes of the State
2 of Idaho.

3 ARTICLE V

4 In no event shall any income or assets of the
5 corporation be distributed to or inure to the benefit of any
6 member, director or officer hereof, either directly or
7 indirectly, other than as bona fide expenses in carrying out the
8 instructions and directions of the Board of Directors and the
9 officer in order to accomplish and achieve the purposes and
10 objectives of the corporation.

11 ARTICLE VI

12 The corporation shall not issue any capital stock, but
13 may issue membership certificates to each member thereof. The
14 membership of the corporation shall be composed of the following:

- 15 (a) One leader from each 4H club organized
16 in Twin Falls County presenting animals
17 for the fat stock sale held annually at
18 the Twin Falls County Fair.
- 19 (b) One leader from each FFA chapter in Twin
20 Falls County presenting animals for the
21 fat stock sale held annually at the Twin
22 Falls County Fair.
- 23 (c) The Twin Falls County Extension Agent.

24 ARTICLE VII

25 Provisions for the regulation of the internal affairs
26 of the corporation shall be as set out in the Bylaws of the
corporation.


