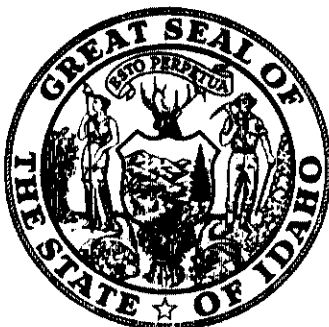

##### AUTHORIZED SHARES OF STOCK
