KNOW ALL MEN BY THESE PRESENTS: That the undersigned, being a natural citizen of full age and a citizen of the United States of America, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the general laws of the State of Idaho, does hereby certify as follows:

ARTICLE I

The name of the Corporation shall be **EZ VINYL FENCING, INC.**

ARTICLE II

The Corporation's purposes are: To carry on any business whatsoever that this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interests of this corporation, and to have and to exercise all powers conferred by the laws of the State of Idaho on corporations formed under the laws pursuant to which and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things herein-above set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations or corporations, and in any part of the world.

ARTICLE IV

ARTICLE V

The total number of shares which the Corporation is authorized to issue is 1000 shares. Said stock shall be no par value stock.

The above named incorporators shall also be the initial Directors.


ARTICLE VII
