ARTICLES OF AMENDMENT CONTINENTAL LIFE & ACCIDENT COMPANY

STATE OF IDAHO, : SS. COUNTY OF ADA.)

W. H. LANGROISE and B. C. TOVEY, being separately sworn each upon oath deposes and says:

That W. H. Langroise is the duly elected, qualified and acting President, and B. C. Tovey is the duly elected, qualified and acting Secretary, of Continental Life & Accident Company; that on June 18, 1964, pursuant to call for a meeting of the stockholders of the Continental Life & Accident Company, issued by the Board of Directors on May 15, 1964, and pursuant to a thirty-day written Notice of the time, place and purpose of the meeting given to all of the stockholders of said corporation, which Notice stated among other things the specific purpose to be to amend the Certificate of Incorporation as amended of said Continental Life & Accident Company, by increasing the number of shares which the corporation shall have authority to issue to 1, 200, 000 shares, each of the par value of 50¢, and of the aggregate par value of \$600,000.00, which said shares shall be common stock, and shall not be subject to assessment.

A meeting of the stockholders of said corporation was duly conveyed and held. Whereas, more than two-thirds of the issued and outstanding shares of said corporation were present and represented; that at said meeting, by resolution duly presented and adopted by the af-

firmative vote of more than two-thirds of the issued and outstanding shares of said corporation, Article V of the Articles of Incorporation of Continental Life & Accident Company, a corporation, was amended to read as follows:

ARTICLE V

That the total authorized par value shares of this corporation shall be one million two hundred thousand (1, 200, 000) shares, each of the par value of fifty cents (50¢), and the aggregate authorized par value six hundred thousand dollars (\$600, 000.00), which said shares shall be common stock, and shall not be subject to assessment.

All of which appears upon, and is of record in, the Minutes of said meeting duly recorded in the Minute Book of said corporation.
