Article 2 (continued)

... within the meaning of Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code.

The purpose of this Corporation is to organize and coordinate churches in Ada County to respond to individual, family, and project needs in the name of Christ, incarnate Son of God, Savior, and Lord. The Corporation will accomplish the following activities: fashion a cooperative helping relationship between area agencies and churches, generate untapped church resources to meet community needs, develop a clearinghouse to screen needs, use community resources, and, as it matures, other initiatives necessary to meet needs.

All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

Article 8 (continued)

... or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
