ARTICLES OF INCORPORATION  
OF  
GRAIN STORAGE INDUSTRIES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is GRAIN STORAGE INDUSTRIES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to engage in the business of storing or handling for hire, or both, grain or other related commodities, and to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000, of a no par value.
