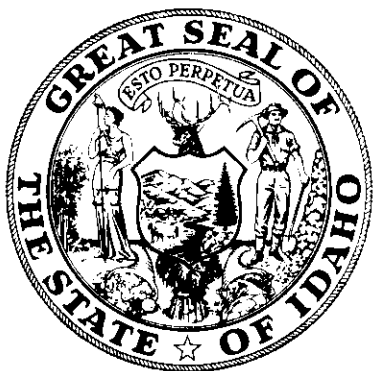

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
PHILLIP O. CARR P. A.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporations Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST. The name of the corporation is Phillip O. Carr P. A.

SECOND. The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on March 28, 1980, in the manner prescribed by the Idaho Business Corporations Act:

ARTICLE I of the Articles of Incorporation shall be deleted and replaced in its entirety by the following new Article I:

ARTICLE I

The name of the corporation shall be PHILLIP O. CARR, D.D.S., P. A..

THIRD. The number of shares of the corporation outstanding at the time of the adoption of said Amendment was 10 and the number of shares entitled to vote thereon was 10.

FOURTH: There were no outstanding shares entitled to vote on the Amendment as a class.

FIFTH: The number of shares voted for such Amendment was 10 and the number of shares voted against such Amendment was 0.


SIXTH: The Amendment does not affect any change,

reclassification, or cancellation of issued shares and does not affect or change the amount of stated capital.


