ARTICLES OF INCORPORATION

OF'

SOUTHGATE WATER ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all being citizens of the United States, of legal age, this day having voluntarily associated ourselves together for the purpose of forming a non-profit association under and pursuant to Idaho Code Section 30-117A, Chapter 1 Title 30 Idaho Code, and the general corporation statutes of the State of Idaho, do hereby certify:

ARTICLE I

The corporate name of this association shall be: SOUTHGATE WATER ASSOCIATION, INC.

ARTICLE II

The purpose or purposes for which said association is formed are:

- (a) To provide a community water system for domestic water use and such other and additional uses as shall from time to time be necessary, excepting irrigation purposes.
- (b) To provide and maintain a well, pumping plant, facilities, pipe lines and any other necessary equipment or facilities to permit the utilization of domestic water and water for other uses to the residences of Southgate Subdivision Number One, according to the official Plat thereof on file and of record in the office of the County Recorder, Canyon County, Idaho, recorded in Book 9 of Plats page 4, on the 21st day of April, 1970, and to the residences of Southgate Subdivision Number Two, according to the official Plat thereof on file and of record in the office of the County Recorder, Canyon County, Idaho, recorded in Book 1 of Plats, Page 28, on the 25th day of October, 1972; and to make other improvements of any kind or nature that may be determined from time to time for the benefit of the residents of said Southgate Subdivision Number One and Southgate Subdivision Number Two.
- (c) To borrow money, issue bonds, mortgages or other commitments as security for money loaned or borrowed.
- (d) To purchase, lease, hold, sell, develop, mortgage, convey or otherwise acquire or dispose of real and personal property necessary or proper for the carrying out of the purposes of this association.
- (e) To do all things permitted of a non-profit association to be done under the laws of the State of Idaho.

ARTICLE III

The term for which this association shall be organized shall be perpetual.

ARTICLE IV

The principal place of business of said association shall be 9th and Dearborn Street, Caldwell, Canyon County, Idaho 83605, c/o Gigray, Downen & Gigray, Attorneys at Law.

ARTICLE V

Any person who shall own or be a contract purchaser within said Southgate Subdivision Number One and Southgate Subdivision Number Two, shall be entitled to become a member of said association. Each member shall be entitled to one vote or fraction thereof, for each lot or fraction thereof of land owned or being purchased by said person in said Southgate Subdivision Number One and Southgate Subdivision Number Two. No stock or shares shall be required to be issued except as may be provided by the By-laws of the association. No share or interest in the association shall be separated or severed from the land and the ownership of the land shall be determinative of the right to exercise the vote of said interest or share in the association, subject to such provisions as may be contained from time to time in the By-laws. Each member's interest in the assets of the association shall be determined by the number of votes to which each member is entitled, provided however, that no dividends or profits of any kind shall ever be declared or paid to the members, except upon liquidation of the association.

ARTICLE VI

The affairs of the association shall be under the control of five (5) directors. Those who shall be directors to manage the affairs of the association for the first year and until their successors are duly elected and qualified are:
