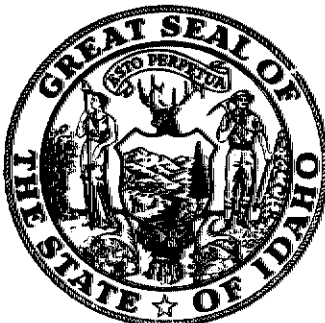

KNOW ALL MEN BY THESE PRESENTS: That We, the undersigned, being a natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

ARTICLE I

The name of the corporation is U.S. CUSTOM CYCLES, INC.

ARTICLE II

The period of duration shall be perpetual.

ARTICLE III

The corporation is organized for the purpose of conducting and transacting any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act. The business shall include, but by no means be limited to, design, assembling, distribution and sales of motorcycles and other associated items.

ARTICLE IV

The aggregate number of shares the corporation shall have the authority to issue is 1,000,000 shares and shall have a NO ( ----- ) PAR VALUE.
