FIRST: The name of this Corporation shall be GENE OAKLUND CONSTRUCTION, INC.

SECOND: This Corporation is formed for the purpose of transacting any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho including, but not limited to the construction business.

THIRD: The period of existence and duration of the life of this Corporation shall be PERPETUAL.
