## CORRECTION OF A FILED DOCUMENT

### *Articles of Correction* *Treasure Valley Community Television, Inc.*

Comes Now, Treasure Valley Community Television, Inc., an Idaho Nonprofit Corporation, designated by the Idaho Secretary of State's Office, Corporations Department, as corporation number C-130070, and according to Idaho Code Section 30-3-6 (1) requests the Secretary of State to correct a previously filed document filed on behalf of said corporation by the past President and past member of the Board of Directors, Bob Neal, on December 30, 2013, entitled Articles of Dissolution for said corporation.

The reasons set forth below will explain the reason why said Articles of Dissolution must be corrected. However, and most importantly, as a result of this request for a Correction of a Filed Document, the current Board of Directors of Treasure Valley Community Television, Inc. requests that **NO FURTHER ACTION BE TAKEN** by the Secretary of State toward Dissolving said corporations and that due to this request to Correct a Filed Document that the Articles of Dissolution be quashed by the Secretary of State. Said Dissolution is currently scheduled to occur on or about January 30, 2014.

Said Idaho Corporation, Treasure Valley Community Television, Inc. (hereinafter referred to as TVCTV) was duly created by the State of Idaho by the filing of Articles of Incorporation on August 13, 1999. It has continuously been in existence since that date. TVCTV has its business office and station facilities currently located at 6225 Overland Road, Boise, Idaho 83709.

TVCTV operated for many years successfully as a Public Access Television Station for the City of Boise. However, during the last few years many of the members of the Board of Directors and the Officers of said corporation have lost both interest and the desire to participate in the corporation which has resulted in a Board of Directors in substantially fewer numbers than required by the company's Bylaws as well as officers that no longer choose to operate and be held responsible for the operations of TVCTV. In late 2013 the situation grew even worse. There was concern that all corporate Board members and officers would simply stop all activity and TVCTV would cease to exist.

As a result of this, in early December, 2013 then President Bob Neal requested that a new Board of Directors be formed to take over the corporation. Since this request was made by Bob Neal a group of concerned citizens in favor of having a vibrant and operating Public Access Television station in Boise, Idaho, formed a new Board for TVCTV. Said Board has met several times in both December of 2013 and January of 2014.

However, after the New Board of Directors was formed (all previous Board members had their term of office expire on December 18, 2013) on December 31, 2013 Bob Neal (TVCTV president) told this group of interested citizens that, "The Station (Treasure Valley Community Television, Inc.) had no legacy worth saving;" and "If the City (Boise City) wanted public access channels they should pay for it." Shortly after these statements were made it was discovered that



said Bob Neal had filed Articles of Dissolution for TVCTV on December 30, 2013 that were to become effective on January 30, 2014.

For the following specific reasons, the previously filed document (Articles of Dissolution for TVCTV) should be corrected and as a result of the correction the Articles of Dissolution should be quashed:

1. The Articles of Dissolution were not approved by a sufficient vote of the Board. A new roster of Officers and Directors was submitted to the then president of TVCTV, Bob Neal which had the correct number of Officers and Directors. In accordance of the TVCTV By-laws these new officers were appointed at open meetings prior to the old officers' term of office ending on December 18, 2013.
2. There was no proper Notice of any meeting regarding the approval of the Articles of Dissolution given to any of the new officers and Board Members and the minutes of any such meeting were not posted at the Corporations place of business as required by TVCTV's Bylaws.
3. Without notice to the new officers and directors, Bob Neal, after his term had expired on December 18, 2013 filed said Articles of Dissolution with Secretary of State.
4. The new officers and Directors of Treasurer Valley Community Television, Inc. are Jon Adamson, President and Director; Bob Nicholas, Vice President and Director; Paul Anderson, Treasurer and Director, Jim Thomas, Secretary and Director, Samuel Bell, Director, Randall Reese, Director, and Mark Akkerman, Director. These officer and Directors executed a Declaration of Successors and Assigns on January 10, 2014 when it became apparent that the Corporations Registered Agent, Bob Neal had not filed notice of the new officers and Board Members with the Secretary of State and yet took it upon himself to dissolve said corporation with no Board of Directors approval in violation of TVCTV's Bylaws.
5. Should the Secretary of State fail to quash the Articles of Dissolution corporate wrong doing may go undetected and or unresolved and a valuable community asset may be lost.
6. Bob Neal's term in office had expired prior to signing the Articles of Dissolution, as well as the other two officers.
7. A new Board and Officers for TVCTV were to take office on December 19th, 2013 but Corporate Agent did not file with Secretary of State the change in Officer and Board status.
8. Bob Neal in getting approval for the Articles of Dissolution did not have sufficient members on Board to have required quorum needed to vote and approve the dissolution of TVCTV.


