



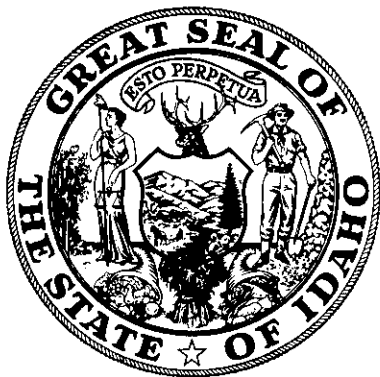
CERTIFICATE OF INCORPORATION

7 The undersigned, acting as incorporators of NEW HOPE
8 DAIRY Co., a corporation under the Idaho Business Incorporation
9 Act, adopt the following Articles of Incorporation for such
10 corporation:

11 FIRST: The name of the corporation is NEW HOPE
12 DAIRY CO.

13 SECOND: The period if its duration is perpetual.

14 THIRD: The purpose or purposes for which the corpo-
15 ration is organized are:

16 (A) To engage in a general livestock, dairy and
17 ranching business, both on its own account and as agent; to
18 agist, feed, graze, manage, herd, control, brand, care for,
19 purchase, market, and sell livestock of every kind, both on its
20 own account and as agent for other persons or corporations; to
21 buy, lease, cultivate, manage, operate, and sell ranch and farm
22 properties and products therefrom both on its own account and
23 as agent for other persons or corporations; and to generally
engage in any and all types of agricultural pursuits or business.

(B) To carry on any other kind of business or business
activities that the Shareholders may from time to time deem to
be advisable or proper in connection with the business.

1 (C) To purchase, lease, own, sell, mortgage, sublease,
2 and otherwise acquire lands, buildings, easements or property,
3 real and personal, which may be requisite for the purposes or
4 are capable of being conveniently used in connection with any
5 of the objects of this corporation, and to enter into, make,
6 perform and carry out contracts of every sort and kind with any
7 person, and to acquire and take over the good will, property,
8 rights, franchises and assets of every kind and the liabilities
9 of any person, firm, association, or corporation, either wholly
10 or in part, and to pay for the same in cash, stocks or bonds of
the corporation, or otherwise.

11 (D) In the purchase of or acquisition of property,
12 business rights or franchises or for any other object in and
13 about its business or affairs, to incur debt and to borrow and
14 secure the payment of money in any lawful manner including the
15 issue and sale or other disposition of bonds, debentures, notes
and other evidences of indebtedness.

16 (E) Without in any particular way limiting any of
17 the objects or purposes or powers of the corporation, the
18 business or purposes of the company shall be empowered from
19 time to time to do any one or more or all of the acts and things
20 herein set forth and to engage in the general commercial
21 business, and all such other acts, things and business in any
22 way connected therewith or auxiliary thereto.

1 (F) To transact any and all lawful business for
2 which corporations may be incorporated under the Idaho Business
3 Corporation Act.

4 FOURTH: The aggregate number of shares which the
5 corporation shall have authority to issue is:

11 Directors for the corporation. The shareholders of the corpor-
12 ation shall serve as the managing or governing body of the cor-
13 poration and shall be responsible for the regulation of the
14 internal affairs of the corporation.
