91 MM 5 ARTICLES OF INCORPORATION OF SOUTHERN TOAHO HOUND ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural citizens of the United States and of full age and majority, have this day and do hereby voluntarily associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

ARTICLE I.

The name of this corporation shall be:

SOUTHERN IDAHO HOUND ASSOCIATION, INC.

ARTICLE II.

The purposes and objects for which this corporation is formed are:

1. To generally engage in, do and perform any non-profit activity to promote the use of hounds.

ARTICLE III.

The corporation shall have a perpetual existance.

ARTICLE IV.

This corporation is one which does not contemplate pecuniary gain or profit to the members thereof and is organized for nonprofit purposes and no part of any net earnings thereof shall inure to the benefit of any member or other individual.

ARTICLE V.

The corporation formed hereby shall have no capital stock, and shall be composed of members rather than shareholders.

ARTICLE VI.

The conditions and regulations of membership and the rights or other privileges of the classes of members shall be determined and fixed by the By-Laws.
