Friends Idaho is a local chapter of Friends of the Children, Inc. (EIN: 93-1300690) which uses a data-driven method to help break the cycle of childhood poverty. Nationally, the children that enter the Friends of the Children program are statistically at risk for dropping out of school, substance abuse, incarceration, and teen pregnancy. . The Friends are all salaried, professional mentors who serve as consistent, positive adult role models in each child's life. The Friends provide guidance, advocacy, tutoring, and mentoring to the children they serve.
