do hereby associate ourselves to-gether for the purpose of forming a corporation under and by virtue of the laws of the state of Idaho relating to the creation of a domestic non-profit corporation.

ARTICLE I

The name of the said corporation shall be Tensed Community Church Incorporated and its duration shall be perpetual.

ARTICLE II

The object, business or pursuit of this corporation shall be to own, operate, and maintain a church for religious purposes, and to assist in all other ways to advance the cause of the Lord Jesus Christ and to acquire, own, sell, mortgage, and dispose of real estate, buildings, anywhere.

ARTICLE III

The estimated value of the property and money possessed by this corporation at the time of making said article is ten thousand dollars, (%10,000.00). The source of revenue and income shall be from sifts, donations, bequests, contributions, and income from investments.

ARTICLE IV

ARTICLE V

The corporate functions of the corporation shall be exercised by a Board of Directors, five in number and a secretary; reserving however the power to increase that number from time to time. The members of the Board of Directors shall be elected by the voting members annually. The annual meeting shall be convened during the fourth week of September each year. The Board of Directors is authorized between the annual meetings to fill any vacancies in its membership because of death, resignation or disability.

ARTICLE VI

The Tensed Community Church shall be a non-denominational church. The Tensed Community Church shall not enter into an alliance to become denominational until such time as there are three denominational churches in Tensed, and only with the written consent of 95% of the elimble voting members. Any agreement entered into
