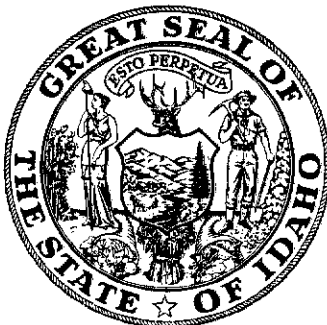

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation of MADER AGENCY, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on the 1st day of July, 1993, in the manner prescribed by the Idaho Business Corporation Act:

III.

The purposes of this corporation are to promote, conduct, provide for and carry on any and all activities in connection with the business and operation of a business enterprise. The corporation shall have the power to do anything not prohibited by law necessary or requisite for the furthering of the purposes of this corporation.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 443,636; and the number of shares entitled to vote thereon was 443,636.

FOURTH: The number of shares voted for such amendment was 443,636; and the number of shares voted against such amendment was 0. All shares issued are one class only, namely a common stock.


