That the purposes for which it is formed are to conduct the business of furnishing abstracts of title up and down stream of property in Shoshone County, State of Idaho; to do all and everything that is essential to the business of examining and furnishing copies of all and everything that may be or become of record on the books of Shoshone County, State of Idaho; legal certificates of title; transact a general insurance business, if required.

That the place where its principal business will be conducted, is Wallace, Idaho.
