



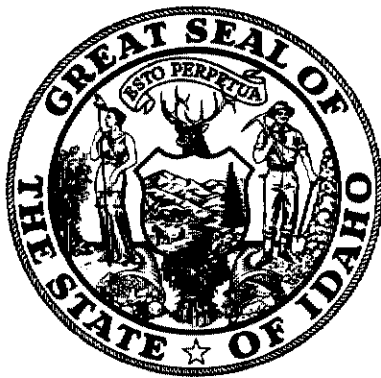
CERTIFICATE OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SUNDALI CONSTRUCTION CO.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100 shares, all of which are to be without par value.

FIFTH: The address of the initial registered office of the corporation is P. O. Box 1884, 731 Paintbrush Lane, Ketchum, Idaho 83340, and the name of its initial registered agent at such address is William C. Sundali.
