#### ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned, being a natural person of full age and a citizen of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, as set forth in Title 30, Idaho Code, Volume 5B, do hereby certify as follows:

I.

The name of the corporation is Shepherd Engineering, Inc.

II.

The purposes for which the Corporation is organized are:

- (a) To engage in every phase and aspect of the business of rendering the same professional services to the public that a professional engineer, duly licensed under the laws of the State of Idaho, is authorized to render, including, but not limited to, the planning, designing, investigating, consulting, evaluating, or supervising the construction or operation of buildings, structures, works, and property, subject to the provisions of 54-1235 Idaho Code, as now enacted or hereafter amended; and
- (b) To offer and provide such allied professional services to the public in connection with providing engineering services now authorized by 30-1303 Idaho Code, or as hereafter enacted;
- (c) To own real and personal property necessary or appropriate for the rendering of the professional engineering IDAHO SECRETARY OF STATE services and to invest the funds of the Corporation in real 19930326 0900 77928 2 estate, mortgages, stocks, bonds, or any other type of CK \$1 8339 CUST\$ 1 investment whatsoever;

(d) To do everything necessary and proper for the accomplishment of any of the purposes, or the attaining of any of the objects or the furtherance of the purposes, enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the Corporation.

The foregoing paragraphs shall be construed as enumerating the purposes of the Corporation and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the Corporation otherwise permitted by law.

III.

This Corporation shall have all the power, authority, and capacity set forth in the Idaho Business Corporation Act as now enacted or hereafter amended, subject only to the limitations stated in the preceding paragraph designated II.

IV.

The Corporation shall have perpetual existence.

V.

The location of the initial registered office of the corporation is

1135 Yellowstone, Suites D & E, Pocatello, Idaho 83201, and L. Wayne Shepherd shall serve as the initial registered agent of the corporation.

VI.

The aggregate number of shares of which the corporation shall have authority to issue is 10,000 shares without par value.

VII.

Each outstanding share of stock shall be entitled to one vote on each matter submitted to a vote at a meeting of shareholders, except that at all elections of the directors of this corporation, each shareholder shall be entitled to as many votes as

shall equal the number of votes which he would be entitled to cast for the election of directors with respect to his shares of stock multiplied by the number of directors to be elected, and he may cast all such votes for a single director or he may distribute the votes among the number of directors to be voted for, or any two or more of them, as he may see fit.

### VIII.

The Board of Directors of the corporation shall consist of one (1) member, unless otherwise modified from time to time by the bylaws of the corporation. The directors shall be elected annually in accordance with the provisions of Idaho Code § 30-1-36, as currently enacted or hereafter amended. There shall be no classification of directors or staggering of their terms.

IX.
