

DESIGNATION OF AGENT AND ACCEPTANCE OF THE PROVISIONS OF
THE CONSTITUTION OF THE STATE OF IDAHO

Know All Men by These Presents:

That The West Cache Irrigation Company (Limited)

a Corporation organized and existing under the laws of the State of Utah
having filed in the office of the Secretary of the State of Idaho a duly authenticated copy of its
Articles of Incorporation, does hereby, in pursuance of the laws of the State of Idaho, make this

to avail itself of the rights, privileges and immunities guaranteed by said Constitution and laws,
does hereby accept the provisions of the Constitution of the State of Idaho for all the intents and
purposes contemplated by the provisions thereof, relating to such acceptance by other than
municipal corporations.
