ARTICLES OF DISSOLUTION OF KETCHCORP, INC.

The undersigned president of Ketchcorp, Inc., an Idaho Corporation, hereby adopts the following Articles of Dissolution.

2. 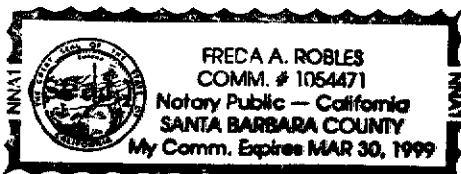
