ARTICLES OF INCORPORATION

OF

THE VISITING NURSE ASSOCIATION OF KOOTENAI COUNTY, INC.

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, all being of legal age and bonafide residents of the State of Idaho, and domiciled therein, have this day voluntarily associated ourselves together for the purpose of forming a charitable non-profit corporation under the provisions of Chapter 10, Title 30, Idaho Code, and to that end do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

Ι.

That the name of said corporation shall be "THE VISITING NURSE ASSOCIATION OF KOOTENAI COUNTY, INC.

II.

That the corporation shall have as its registered office in the City of Coeur d'Alene, County of Kootenai, State of Idaho, and the office address of the registered office for said corporation in the State of Idaho shall be:

The Visiting Nurse Association of Kootenai County, Inc c/o Kootenai County Health Unit Kootenai County Courthouse Government Way Coeur d'Alene, Idaho

III.

The objects, purposes and powers of this corporation are:

(1) To aid, assist and nurse those persons in Kootenai County,
State of Idaho, whose physical condition would be advanced by the visitation of individuals qualified in the field of home nursing.

- (2) To provide such skilled nursing care for the sick in their homes, or visit on a part-time basis or otherwise, pursuant to such rules, regulations and customs as the Board of Directors of said corporation may from time to time fix and promulgate.
- (3) To assist with and join with Health Clinics, Health Units and other corporations, organizations or associations interested in the prevention of diseases in the furtherance of the health of individuals, families and community and to coordinate and promote the teaching of principles of health, hygiene and sanitation and to do and perform every act or activity that appears to be necessary or convenient in connection with the above named purposes.

IV.

The term for which this corporation shall exist is perpetual from and after the date of its incorporation.

V.

Said corporation shall be managed by a Board of Directors of not less than five (5) or more than fifteen (15) members.

VI.

Its officers shall consist of a President, a Secretary and a Treasurer, who shall be elected as provided by the By-Laws of this corporation.

VII.

This corporation shall not be operated for profit nor shall said corporation issue any capital stock. It is not anticipated that there will be profit or surplus from the operation of such corporation, but if such profit or surplus does occur, then such profit or surplus shall be used to further the projects, objects and purposes of this corporation

PROVIDED, FURTHER, HOWEVER, that in no event shall the profits or surplus of the corporation be paid to any officer, director or member by way of salary, dividend or otherwise. That said corporation is further organized pursuant to the provisions of Section 501 (c) (7) Internal Revenue Code of 1954 and in conformity with the provisions of Title 15, Section 77-C (4) United Code Annotated and no part or earnings of said corporation shall inure to the benefit of any person, private member, officer or director of said corporation.

VIII.

That no person, by virtue of race, creed or color, shall be denied membership in this corporation by virtue of such race, creed or color, or be denied the services and undertakings contemplated by said corporation, solely by virtue of race, creed or color. The rights and interest of members herein shall be equal, and no member can have or acquire a greater interest than any other member.

IX.

The number of directors who shall manage and conduct the affairs of the corporation shall be prescribed by the By-Laws. One-third (1/3) of said number so prescribed shall be elected for a period of one year; one-third (1/3) of said number for a period of two years; and one-third (1/3) of said number for a period of three years. Thereafter at each succeeding annual election meeting of the members of this corporation, there shall be elected one-third (1/3) of the number comprising the Board of Directors as prescribed by the By-Laws. No person can be a director in this corporation unless he or she has been a member thereof; no person can become a member until he or she has been duly accepted as a member in accordance with the By-Laws of the corpora-

tion and the statutes of the State of Idaho so controlling, nor transfer of any membership shall be permitted or allowed by the By-Laws.

Χ.

This corporation shall have the right to adopt By-Laws in accordance with the provisions of Section 30-1005 Idaho Code.

XI.

These Articles of Incorporation may be amended in any manner at any regular meeting of the directors of the corporation by a vote of a majority of a quorum attending such meeting, provided public notice of the intention to amend the Articles of Incorporation and notice of the time, place and date of such meeting shall have first been given by publication at least once a week for four weeks in a legally published newspaper in Kootenai County, Idaho. The notice shall designate whether it is a regular or special meeting and shall further state in what manner it is intended to amend the Articles of Incorporation.
