### CERTIFICATE OF INCORPORATION

*I, J. D. (CY) PRICE, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of*

**TEN MILE RIDING CLUB, INC.**

*was filed in the office of the Secretary of State on the **Twenty-first** day of **February** A. D. One Thousand Nine Hundred **Forty-eight** and is duly recorded on Film No. **12** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 29-103 and Sections 29-1001 to 29-1005, inclusive, Idaho Code, Annotated.*

*I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for perpetual existence from the date hereof, with its registered office in this State located at **Kuna** in the County of **Ada** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations, as provided in Chapter 10, Title 29, Idaho Code, Annotated.*

ARTICLES OF INCORPORATION  
OF  
TEN MILE RIDING CLUB, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are bona fide residents of the State of Idaho and of full age, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of Title 29, Chapter 10, Idaho Code Annotated, and do hereby certify, adopt, sign and acknowledge these Articles of Incorporation as follows:

ARTICLE I.

The name of this corporation shall be, "TEN MILE RIDING CLUB, INC."

ARTICLE II.

The corporate existence of this corporation shall be perpetual.

ARTICLE III.

The place where the principal business of this corporation shall be transacted is Kuna, Ada County, Idaho, and the location and post office address of its registered office shall be Kuna, Ada County, Idaho; meetings of directors may be held either within or without the State of Idaho.

ARTICLE IV.

This corporation shall be non-stock and no dividends or pecuniary profits shall be declared to the members thereof.

#### ARTICLE V.

The general officers of said corporation shall be five, and the board of directors shall consist of at least three members, said officers and directors to be elected as hereinafter provided.

#### ARTICLE VI.

The duties of the officers, in no way contrary to the laws of the State of Idaho, shall be fixed by the board of directors.

#### ARTICLE VII.

The officers shall be elected in such manner as may be directed by resolution of the Board of Directors and shall hold office for one year and until their successors have been elected and duly qualified. The Board of Directors shall be elected at the annual meeting of the membership in good standing and shall hold office for one year.

#### ARTICLE VIII.

The membership dues shall be fixed annually by the Board of Directors at their first meeting after January 1st, and shall remain as fixed by said board during the ensuing year, and all members who have paid the assessed membership dues for said year shall be considered members in good standing in this club.

#### ARTICLE IX.

Section 1. Membership in this corporation shall consist of all persons of good character and repute over the age of sixteen years who are willing to subscribe to the objects of this club and its code of ethics.

Section 2. A member who violates any of the ethics or rules of this club may be expelled from membership by a two-thirds vote of the Board of Directors present at a regular board meeting.

#### ARTICLE X.

The purposes for which this corporation is formed are as follows:

(a) To encourage the riding and breeding of saddle horses; to promote, manage and operate rodeos, fairs and carnivals, or any other amusement in connection with any of the above activities not contrary to the laws of the United States or the State of Idaho.

(b) To own, buy, sell, trade, exchange and manage both real and personal property which may in any manner be conducive or advantageous to the general purposes for which this corporation is organized; to borrow or lend money, to become mortgagor or mortgagee, as the case may be and as may be necessary for the purposes of this corporation.

(c) To raise money by subscriptions and grant any rights and privileges to the subscribers as may be expedient, and to do any and all things not contrary to the laws of the State of Idaho, the United States, or the City of Kuna, which may be necessary, convenient or advantageous to the purposes for which this corporation is organized.

#### ARTICLE XI.

(a) Subject to the provisions of the corporation laws of the State of Idaho, the directors shall have power to repeal and amend by-laws and adopt new by-laws for the corporation.

(b) The directors, by a suitable by-law or by resolution passed by a majority of the whole membership of officers

may designate one of their number as general manager, or may retain a non-member as general manager of the corporation, and may pay him such salary as they deem proper, or may let or lease the chattels, embellishments and equipment of said club upon such terms as they deem expedient.

(c) Subject to the provisions of the Statutes of Idaho, the corporation may, through appropriate by-law provisions, confer powers upon the Board of Directors in addition to the powers expressly conferred upon it by law and this Certificate.
