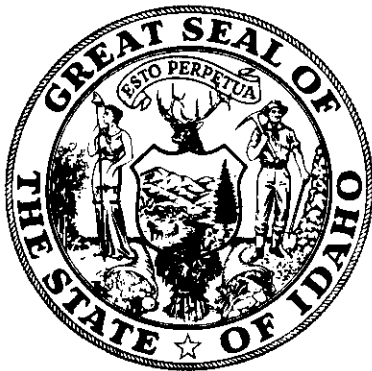

OF

1. The name of the corporation is National Marketing and Manufacturing, Inc.

2. The period of its duration is perpetual.
