We, ROBERT G. PIRNER and WILBER L. HOVE, Pastor and Secretary respectively, of American Lutheran Church of Twin Falls, Idaho, Inc., a corporation, do hereby certify:

That American Lutheran Church of Twin Falls, Idaho, Inc. was duly incorporated as a religious corporation under the laws of the State of Idaho on June 10, 1944;

That public notice of intention to amend the Articles of Incorporation of said corporation was given by publication once a week for four weeks in the Times-News, a newspaper published in Twin Falls County, in which County the meeting hereinafter referred to was held, in the issues of said newspaper published November 17, 1960; November 24, 1960; December 1, 1960, and December 8, 1960; that such notice designated December 11, 1960, at 12:00 o'clock noon and American Lutheran Church, 340 Second Street North, Twin Falls, Idaho, as the time and place for holding a regular meeting of the corporation at which it was intended to vote on the proposition of amending its Articles of Incorporation to change the name of the corporation from American Lutheran Church of Twin Falls, Idaho, Inc., to Our Savior Lutheran Church of Twin Falls, Inc.;

That at a regular meeting of the members of said corporation held pursuant to said notice and at the time and place specified therein, at which a quorum was present, a majority of said members attending such meeting duly adopted the following amendment to the Articles of Incorporation of said corporation, to-wit:

That Article I of the Articles of Incorporation of American Lutheran Church of Twin Falls, Idaho, Inc. be and the same is

hereby amended and changed by striking therefrom said Article I and substituting in lieu thereof the following, to-wit:

***ARTICLE I.**

That the name of this corporation is and shall be
OUR SAVIOR LUTHERAN CHURCH OF TWIN FALLS, INC.*

Except as amended above, all of the original provisions set forth in said Articles of Incorporation shall remain in full force and effect and are hereby in all respects ratified and confirmed;

We further certify that we were present at said meeting and that we make this certificate as to the amendment of said Articles pursuant to the provision of Chapter 11, Title 39, Idaho Code.
