WHEREAS, in many states the corporate name "Sign Up Company" has been reserved,


WHEREAS, it is now deemed necessary to operate under a different business name in those states,

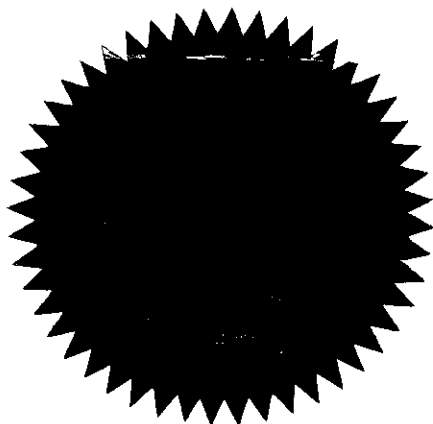
