The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE ONE: Name. The name of the corporation is KNOLES LOGGING, INC.

ARTICLE TWO: Purpose. The purpose of the corporation is to engage in any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE: Duration. The period of duration of the corporation is perpetual.

ARTICLE FOUR: Registered Office and Registered Agent. The address of the corporation's initial registered office in the State of Idaho is 811 First Avenue, Priest River, Idaho 83856. The name of the corporation's initial registered agent at such address is Karla A. Knoles.


