The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the statutes of the State of Idaho, adopt the following articles of incorporation:

ARTICLE ONE: NAME. The name of the corporation is Grand View Ranch Association, Inc.

ARTICLE TWO: NON-PROFIT CORPORATION. This corporation is a non-profit corporation.

ARTICLE THREE: DURATION. The period of duration of the corporation is perpetual.

ARTICLE FOUR: PURPOSES. The purposes of this corporation shall be to exercise duties commonly associated with a community association in developing a community for safe, healthful, and harmonious living; to promote the collective and individual property interests of the members of this corporation; to acquire, own, or lease such real and personal property as may be necessary or convenient for the fulfillment of its purposes; and in general, in connection with the foregoing, to do any and all things necessary or convenient to further these purposes as set forth in the bylaws of the corporation.

ARTICLE FIVE: NON-STOCK CORPORATION. The corporation shall be non-stock.

ARTICLE SIX: REGISTERED OFFICE AND REGISTERED AGENT. The address of the corporation's initial registered office in the State of Idaho is 520 South 7th Avenue, Pocatello, Idaho, 83201. The corporation's initial registered agent at such address is Daniel R. Smith.

ARTICLE SEVEN: DIRECTORS. The number of directors constituting the initial board of directors is 3 and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualify are:
