ARTICLES OF INCORPORATION

OF

R & J, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is R & J, Inc. NAME.

ARTICLE II

DURATION. The period of its duration is perpetual.

ARTICLE III

PURPOSE. The purpose for which the corporation is organized is to engage in the transaction of any and all lawful business for which corporations may be incorporated under the provisions of Chapter 1, Title 30 of the Idaho Code and any amendments thereto, commonly known as the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100,000. Said stock shall be of one class designated as common stock without par value.

ARTICLE V

PREEMPTIVE RIGHTS. There are no provisions denying preemptive rights.

ARTICLE VI

INTERNAL AFFAIRS. There are no provisions for the regulation of the internal affairs of the corporation, excepting that the voting rights of the common capital stock shall not be cumulative when voting for the election of directors.
