The undersigned, in order to form a corporation pursuant to
the Idaho Business Corporation Act, certify as follows:
ARTICLE I
The name of the corporation isA M U Inc.
(hereafter "Corporation").
ARTICLE II
The purposes for which this Corporation is organized are
as follows:
1. To engage in <u>Maintenance</u> ; and
2. To engage in any other lawful activity or business for
which corporations may be incorporated under the Idaho
Business Corporation Act.

The Corporation shall have perpetual existence.
