The undersigned, in order to re-state the Articles of Incorporationate Filed: 2/1/2021 12:38:00 PM Disposal Service, Inc., originally incorporated in Idaho on August 27, 1959, said restated Articles of Incorporation to include all properly approved amendments from time to time since incorporation, do hereby, pursuant to the provisions of IDAHO CODE Title 30, Chapter 29, Part 10, submit these ARTICLES OF RESTATEMENT to the Secretary of the State of Idaho, as follows:

- 1. Name of Corporation: The name of the corporation is unchanged and shall continue to be CARROLL-NASLUND DISPOSAL SERVICE, INC.
- 2. Authorized Shares: This Restatement does not provide for any change in corporate shares. There shall continue to be one class of common stock. The number of shares the corporation is authorized to issue shall continue to be 50,000 shares of voting common stock, with a par value of \$1.00 each.
