ARTICLES OF INCORPORATION

RESOLVALL WELL BY THESE PRESENTS, That we the undersigned being natural persons of full age and at least 2/3 of them being citizens of the United States, in order to form a corporation for the purposes mereinafter stated, pursuant to the Business Corporation Act of Edaho, do hereby certify as follows:

I.

The name of the corporation is the Triple T. Ranches, Inc.

The purposes for which said corporation is formed are:
To conduct a general brokerage, atency, and commission business
for others in the purchase, sale and management of real estate
for others and the negotiation of loans thereon; to purchase and
sell for others personal property; stocks, sonds, and notes, and
to negotiate loans thereon for others; to act as trusted on
deads of trust for mortgages on real or personal property or any
evidences of value to secure them, and to act as agents for
letting nouses, lands, and the collection of rents and the
payments of taxes and to own or manage any personal property
including livestock in connection with any of the properties
owned by the corporation or managed by it.

The corporation is to have perpetual existence.

In furtherance and not limitation of the general powers conferred by the laws of the State of Edaho, and the objects and purposes merein set forth, it is expressly provided that this comporation shall also have the following powers, viz.:

Such real and versonal property of every kind and description within and without the State of Micho, and in any gast of the world, suicable, accessary, useful or a visable in connection with any or all of the objects hereinbefore or nereinafter set forth, and to convey, sell, assish, transfer, lease, mortgage, pleade, exchange or otherwise dispose of any such property.

The recitation of the foregoing particular powers thall not be deemed to be an exclusive list of the powers to be possessed by the comporation, but shall be deemed powers in addition to all other lawful powers not inconsistent therewith as shall be conferred upon this comporation by the statutes of the State of Edaho.

VI.

The number of the directors of the corporation shall be four, and each of them must be a shareholder of this corporation, owning at least one share of its capital stock.

VII.

There shall be one class of capital stock of this corporation and it shall be known as common stock. The amount of common stock is \$100,000.00 divided into 50,000 shares as the par value of \$2.00 per share, said stock to be non-assessable.

In case a stockholder desires to sell his share or shares of stock, he must first offer it for sale to the remaining

preference to the purchase of the same and any attempted sale in violation of the provision is null and void. A stockholder desiring to sell his stock shall file notice in writing with the secretary of the comporation stating the terms of sale and unless his terms are accepted by any or all of the other stockholders within thirty days thereof, there shall be deemed to have valved their privilete of surshasing, and he be at liberty to sell to anyone class on the same terms that were offered to the other stockholders.
