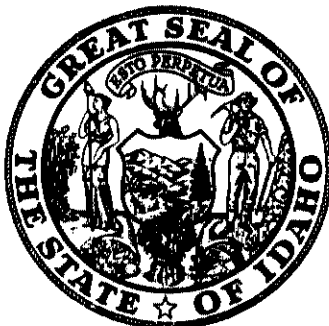
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

RITTER CONSTRUCTION, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is: **RITTER CONSTRUCTION, INC.**

SECOND: The period of its duration is: **Perpetuity**

THIRD: The purpose or purposes for which the corporation is organized are: The transaction of a business and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100,000. The shares shall have no par value.

FIFTH: The address of the initial registered office of the corporation is 1820 Lakeview Lane, Coeur d'Alene, Idaho 83814, and the name and address of its initial registered agent is: Brent C. Ritter, 1820 Lakeview Lane, Coeur d'Alene, Idaho 83814.
