ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation;

FIRST: The name of the corporation is CUSTOM PRINTING AND BROKERAGE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares with a par value of \$1.00 per share for a total authorized capital stock of Fifty Thousand Dollars (\$50,000.00), all of which shall be non-assessable, common stock with equal voting and other rights and privileges.
