THE UNDERSIGNED, a natural person over the age of eighteen (18) years, does hereby form a corporation under the laws of the State of Idaho, as contained in Chapter 1 of Title 30, Idaho Code, entitled "Idaho Business Corporation Act," and to that end does hereby certify:

ARTICLE I

Name

The name of said corporation shall be Fox & Garcia Marketing, Inc.

ARTICLE II

Purposes and Powers

C. To engage in all legal business activities as may be authorized or permitted by the Idaho Business Corporation Act (Chapter 1 of Title 30, Idaho Code).

ARTICLE III

Duration

The duration of the corporation shall be perpetual.

ARTICLE IV

Registered Office

The registered office of said corporation in the State of Idaho shall be located at 320 Second Avenue North, Twin Falls, Idaho, in the County of Twin Falls, Idaho. Kelly J. Fox shall be the registered agent at the address set forth above.

ARTICLE V

Corporate Stock

The corporation is authorized to issue two (2) separate classes of common stock, as follows:

1. Two Thousand (2,000) shares of Class A stock, and $\frac{100.00}{100.00} = 100.00$ CORP

2. Two Thousand (2,000) shares of Class B stock.

Both Class A stock and Class B stock shall be no par value common stock, and shall be different only in voting rights. Class A stock shall be voting stock, with one (1) vote appurtenant to each share of such stock issued, exercisable, in person or by proxy, by the owner(s) thereof. Class B stock shall be non-voting stock.

ARTICLE VI

Management

Fox, 320 Second Avenue North, Twin Falls, Idaho 83301 who shall serve until the first annual meeting of the shareholders or until his successor has been duly elected and qualified.

ARTICLE VIII

Bylaws

The regulation of the internal affairs of the corporation shall be further detailed and provided for in the Bylaws of the corporation. The power to adopt, repeal and amend said Bylaws shall be in the shareholders.
